## WISCONSIN BLACK HISTORICAL SOCIETY/MUSEUM TO KICK OFF KWANZAA ON DEC. 26

The Wisconsin Black Historical Society/Museum (WBHSM) will again host the state's largest Kwanzaa celebration December 26. Doors will open at 5:30 p.m.

Kwanzaa, an African American and Pan-African holiday, is a weeklong celebration honoring African American culture and African heritage. Its principles promote and celebrate history, values, family, community, and culture. Kwanzaa begins on December 26 and ends on January 1, 2025.

It was created in 1966 by Maulana Ron Karenga. In 1967 Karenga visited Milwaukee to participate in the second-ever public celebration of Kwanzaa. The word Kwanzaa comes from the Swahili phrase "matunda ya kwanza" or "first fruits," referencing the African harvest

festivals on which the celebration is based. Many who celebrate Kwanzaa also celebrate Christmas or other seasonal holidays. "I credit long-time WTMJ-TV reporter/anchor Bill Taylor (recently deceased), for helping me fully understand and embrace the

# What you need to know about celebrating Kwanzaa!

Celebrated every year from December 26 through January 1, Kwanzaa is a week of festivities honoring African American culture and heritage.

Friends and family gather each day to give thanks, exchange gifts, and share feasts.

The holiday was created in 1966, during a time period when many Black people faced unfair treatment because of their skin color.

The holiday honors African American people, their struggles in the United States, their heritage, and their culture.

Here are some things to know about celebrating Kwanzaa:

Kwanzaa is based on seven guiding principles, or 'Nguzo Saba,' which are meant to be incorporated into daily life:

- Umoja: Unity
- Kujichagulia: Self-

- determination
- Ujima: Collective work and responsibility
- Ujamaa: Cooperative economics
- Nia: Purpose
- Kuumba: Creativity
- Imani: Faith

- How it's celebrated**  
 Kwanzaa celebrations often include:
- Lighting a candle in the Kinara, a candle holder, each night to represent one of the seven principles
  - Spreading out an African cloth

on a table, then the mat, and then the other symbols

- Singing, dancing, storytelling, poetry reading, and African drumming
- Feasting on traditional African dishes, such as catfish, collards, macaroni and cheese, jerk chicken, gumbo, accras, and feijoada

**What the symbols mean**  
 The seven symbols of Kwanzaa are:

- Kinara: A candle holder
  - Mishumaa Saba: Seven candles
  - Mkeka: The mat
  - Mazao: Crops
  - Muhindi: Ears of corn
  - Kikombe Cha Umoja: A unity cup
  - Zawadi: Gifts

# A Hard life's lesson learned too young!

Imagine this surreal scene: It's recess time at a suburban elementary school. MJ and his new friend—both five years old—are standing around the playground when an older student passes by, waving to MJ.

"Hi, Budda," MJ shouts before turning to his new friend; that's my cousin," he remarks, sparking a look of disbelief on his friend's face.

"Naw, he can't be your cousin," the friend states bluntly. "He's Black," an element of disdain in his voice.

A curious look immediately replaces the smile on MJ's face. "Yeah, he is," he asserted.

"No, can't because you're White," the Caucasian child declared.

His disingenuous statement prompted a look of confusion on MJ's face, which would remain until he arrived home later in the afternoon, immediately quizzing his mother about his friend's statements.

"Mama, my friend said Budda can't be my cousin because he's Black."

The statement surprised my daughter-in-law. She paused momentarily before putting MJ on her lap to explain a reality that would alter her young son's perception of who and what he is.

His mother's response would erase MJ's youthful reality and add a new dimension of race and racism to his vocabulary, stripping from the tot his belief in fairy tales, cartoons, and a color-blind society.

"Budda is your cousin, and he's Black. You are also Black, even if you look White," she told the bewildered kindergartener.

The mother painfully explained that he and his sister were Black, biracial—even though she too may look white, and his father was black.

The answer left MJ even more confused.

"His sister was light, but not White, as in the crayon coloring. Nor was his father 'black' as that crayon's color, but Black as in how people see him."

They were all shades of the rainbow, rooted in Blackness.

In those few seconds, my BD ('bonus daughter') realized that she was essentially stripping away MJ's innocence while adding a confusing dimension to his worldview.

She also realized her explanation was nonsensical in many respects, as she could not explain artificial versus God-made distinctions to an innocent five-year-old.

What was race to a five-year-old? Why did it make a difference? And how could MJ be considered 'black' (whatever that implied) when he looked in the mirror and saw someone who looked like his father and me—eyes, nose, and facial construct) but was (or would be) considered white, whatever that means to an innocent child.

The episode brought to mind the day I took my 'brown-skinned' five-year-old granddaughter to a suburban McDonald's child's area where she played freely with several White kids.

I observed the children laughing and playing until one of the White kid's mothers saw them and broke up the party, pulling her infant daughter away.

The child protested, puzzled by the disruption and claiming she hadn't done anything wrong. Nonetheless, the mother scolded her and pulled her to their table.

Only I knew the truth. And it was painful. My granddaughter had some racial disease that would be passed on.

I tried to get the mother's attention, thinking of cussing her out, but given the senselessness of convincing a stupid racist of the error of her ways, I shook my head and withdrew.

I did not explain to my granddaughter what had transpired. How do you define racism, ignorance, and ugliness?

Instead, I decided to increase the frequency of my assertions to my granddaughter that she was a Fula Princess, a descendant of royalty, someone special. It would be her shield against ignorance, for it was a fact.

I learned of MJ's encounter from my bonus daughter during our weekly family day. It nearly brought me to tears.

Not just because MJ lost his racial virginity but because he now faces a world, a society that is defined by colorism.

His 'White' friend had to learn of the racial distinction from his parents or friends, just as a seven-year-old White bigot-in-training 50 years ago called me a nigger (n-word) when I participated in the open housing marches.

The issue at the time was White people's refusal to allow Black Milwaukeeans to live among them on the south side of Milwaukee.

Thousands of Black (and White) 'freedom warriors' marched for over 200 days in support of an open housing ordinance proposed by the city's lone Black alderman at the time (Vel Philips) to end housing covenants that fueled apartheid.

On the day in question, I lost my innocence, seeing the devil of bigotry up close and personal.

I almost cried because I recognized the sins of hatred that filled my being for Whites who blocked equal rights or thought they were somehow superior. And for my feelings of inferiority that was bred into people of color.

I consciously withdrew from an emotional response to my BD's tale because I was forced to come to grips with the reality that my grandson would have to endure the byproducts of colorism—racism—probably for the rest of his life.

Ironically, he would be rejected and scorned by some African Americans because they envied his straight hair and White (that word again) skin. Because of his ability to escape the challenges of Blackness—rejected for loans and jobs but able to join White-only golf clubs, being treated more respectfully, and travel without being profiled.

Conversely, we have been inoculated to believe colorism is a God-ordained reality—the lighter, the better, the more beautiful, and the more acceptable.

Many Black folks refuse to admit they believe white ice is colder. You see it in the wigs, skin-whitening creams, and col-

ored contact lenses.

I withheld tears because while much has changed, this melting pot of races, creeds, and cultures still has yet to blend into the quilt that Rev. Jesse Jackson once described as a hopeful goal of America and Americans.

I withheld an emotional outburst because it took me a lifetime to realize colorism is the penultimate sin, that White is a construct, not a reality. That there is only one race—the human (or as I sometimes call it) the 'hue-man' race, and we are all victims of a grandiose scheme to divide and conquer.

And the difference between us is about culture and ethnicity, not race, which in itself is a disingenuous lie.

I withheld tears because I had to face the reality that MJ would grow up in a societal reality in which some Black and many Whites would reject him for disingenuous reasons.

After all, he looks White—or should I say Caucasian—and either out of jealousy (a sad byproduct of self-hatred) or disdain, some insecure Black folks would take out

their frustrations on him.

Conversely, many Caucasians would not consider him entirely White (even though he looked like them), assuming he must be inferior because of their need to feel superior.

Colorism is not as imposing as it once was. However, racism is making a reappearance under the mask of politics and religious schemes. There are still places in Wisconsin where we are not wanted, places with 'sundown' provisions.

Last Sunday, the Journal Sentinel ran stories on football legend Reggie White, who, while ministering in Milwaukee, once revealed being stopped by Green Bay police who thought he was driving around town with a white woman (who was a light-skinned Black woman).

Before it was clarified, he was charged with violating the unwritten law of interracial relationships.

The color of his skin will not judge my beautiful, intelligent Black/White grandson, but because of it. He will be too white for Black and too Black (a drop of Black blood) for White.

It is an age-old dilemma, but one that is no less problematic and disingenuous in 2024 than it was in 1823.

It is at the root of why America is on the brink of civil war in 2024 as it was in 1861.

Pessimistically, my grandson's envious—albeit potentially painful—position may provide the patented solution to the cancer that ails America.

To be a colorless society, we must mix the colors and rid ourselves of colorism. And if we can't do that morally, we can do it physically.

My look-like-he's-White grandson, the love of my life, is either the solution or the problem.

Beyond his new reality, I also wonder what his young White friend would think about him when he explains that he is Black--African American, a prince of the Fulani tribe of West Africa.

How MJ's 'friend' responds will determine my prince's worldview and his place in our reality. —Hotep.

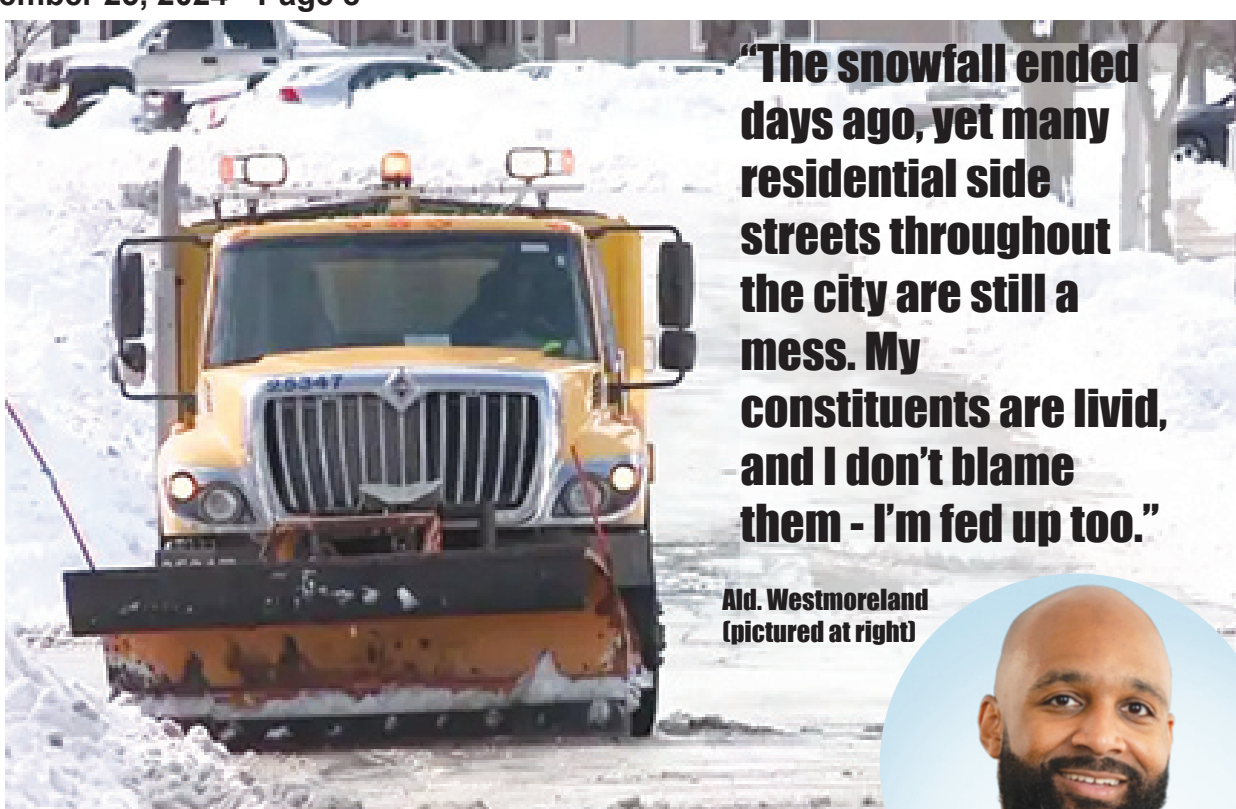
However, nearly a year later, with far less snow to deal with, we're back to square one. Same inadequate services.
